With cheque No 119 can we cancel the cheque with out cancelling it at the Bank?

Neil has lost a cheque from Townsville District Bowhunters after he receipted it (Receipt No 90). He sent a letter to the club stating he had lost the cheque could they cancel it and send another one out, he never notified us of the lost cheque or the letter. The Townsville club is now sending us a bill to cover the cost of the cancellation fee.

In our deposit book problem (A) I cannot find the \$700.00 cheque in our books anywhere and when you add up the amounts on the slip to the total they are incorrect the amount on the deposit slip and the bank statement match.

The only other question is has the auditor done his job and if not what can we do about it.






