1. If Townsville District Bowhunters equipment and grounds are used by the Girl Guides in this Corporate Archery Instructors Course. And if someone is injured on the day, are we liable for any injuries incurred.
2. 6. If national sanction this training will the Director of Coaching Dane Lane and the National President Michael White sign off on it.

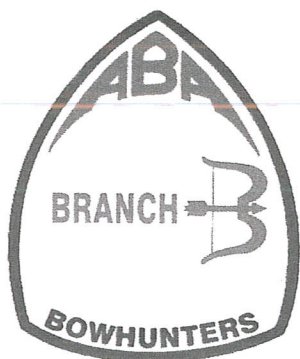

Guide lines for being graded

To be able to grade a shooter there are a few things people need to be made aware of.

Independents - Meaning People who are not members of a club are not graded by the Score Recorder Program (even at a National Level this is not done) A person becomes an Independent by not filling in their ABA application form fully eg Not Nominating the club you are a member of.

ABA Grading rounds - To be graded you MUST shoot 3 ABA rounds with in a 12 month period in a single division eg, Bowhunter Compound. If you shoot more than one division eg Longbow Modern and Bowhunter Compound you need to shoot 3 ABA rounds in each division within a 12 month time frame to get graded in each division.

Correct Divisions – It is the shooters responsibility to know what division they are shooting and make sure they supply the correct information to the Club Score Recorder when they nominate. If you are not sure of your division see your Club Coach or Instructor or Score Recorder for conformation.

Scores - Once the shoot has finished the Club Score recorder sends all the shoot details being The Date of the Shoot, The Club where the shoot took place and the Names, ABA numbers, Shoot Divisions, 3 Arrow and 1 Arrow and the Totals to the Branch Score Recorder who then puts all of the information that the Club Score Recorder supplied into the computer. Nationals need to receive these scores within 14 days of the shoot date to be counted as official shoots so we can grade people. If members are not financial they will not receive a grade from the programme.

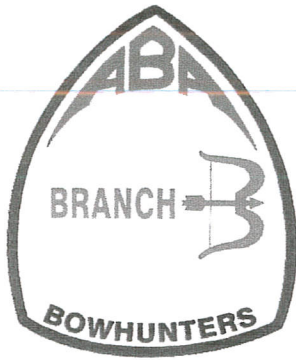

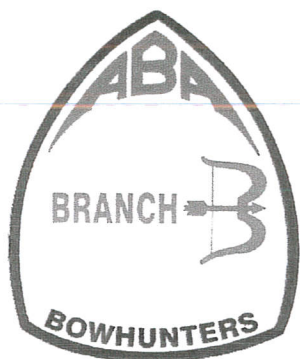

I am writing to request the dates 20 – 22nd march 2015 be inserted into the current club calendar.

The purpose of this inclusion is to run a Bowhunter Proficiency training and assessment weekend to ensure club members who have met the ABA requirements are suitably prepared and deemed competent to undertake the Bowhunter Proficiency Assessment.

The weekend will consist of basic theory and practical training in subjects included in the National Bowhunter Education Manual such as land navigation, survival, first aid, tracking and ethical hunting practices, as well as shooting and range estimation techniques including the correct use of the range finder in real time hunting scenarios. The weekend then will culminate in the BPC assessment.

Training will commence from 0800 on Saturday 21st of March and consist of both theory and practical instruction finishing with the BPC theory test. I estimate training will be completed no later than 1800 pending retest. I expect the course to be complete no later than 1300, to allow participants from outside Townsville sufficient travel time to return home Sunday afternoon


No training will be conducted on the 20th but is requested to cover members from other areas should they choose to travel to Townsville and camp at the grounds prior to and for the duration of the course.

Primary instructor for the duration of the course will be myself. Should there be a greater turnout/interest then my intent will be to use proficient club members with the relevant experience as assistant instructors. I also request one qualified coach to be present to supervise the range on Sunday morning. If no coach is available I can fill this position. I will be the primary assessor for the course and have the required papers including theory tests and assessment proforma.

This weekend will be open for all members to attend and participate in but only members who have been a financial member of ABA for a period greater than 3 months will be eligible for their BPC assessment. If possible and pending attendance conformation I request the bar made available for the duration of the course, with the possibility of the club providing lunch and/or dinner on the Saturday and lunch Sunday.

The purpose of this inclusion is to run a Bowhunter Proficiency training and assessment weekend to ensure club members who have met the ABA requirements are suitably prepared and deemed competent to undertake the Bowhunter Proficiency Assessment.

The weekend will consist of basic theory and practical training in subjects included in the National Bowhunter Education Manual such as land navigation, survival, first aid, tracking and ethical hunting practices, as well as shooting and range estimation techniques including the correct use of the range finder in real time hunting scenarios. The weekend then will culminate in the BPC assessment.

Training will commence from 0800 on Saturday 21st of March and consist of both theory and practical instruction finishing with the BPC theory test. I estimate training will be completed no later than 1800 pending retest. Sunday training will commence no later than 0800 and consist of theory in regards to bow tuning and correct set up, followed by practical shooting on an unmarked range and culminating in the BPC accuracy test. I expect the course to be complete no later than 1300, to allow participants from outside Townsville sufficient travel time to return home Sunday afternoon

No training will be conducted on the 20th but is requested to cover members from other areas should they choose to travel to Townsville and camp at the grounds prior to and for the duration of the course.

Primary instructor for the duration of the course will be myself. Should there be a greater turnout/interest then my intent will be to use proficient club members with the relevant experience as assistant instructors. I also request one qualified coach to be present to supervise the range on Sunday morning. If no coach is available I can fill this position. I will be the primary assessor for the course and have the required papers including theory tests and assessment proforma.

This weekend will be open for all members to attend and participate in but only members who have been a financial member of ABA for a period greater than 3 months will be eligible for their BPC assessment. If possible and pending attendance conformation I request the bar made available for the duration of the course, with the possibility of the club providing lunch and/or dinner on the Saturday and lunch Sunday.

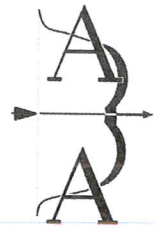
